Vacancy – Post of Engineer, Rolling Stock

The **Metro Express Limited (MEL)** is a registered Mauritian Company wholly owned by the Government of Mauritius and the Company is responsible for the developing, financing, constructing, operating and managing the Metro Express Light Rail System in Mauritius.

Applications are invited from suitably qualified candidates who wish to be considered for the post of **Engineer**, **Rolling Stock** in the **MEL**.

A. Qualifications

Candidates shall have the following attributes:

- a) Possess a Bachelor degree in Electrical or Mechanical Engineering discipline from a recognised University or an equivalent qualification acceptable to the Board of MEL;
- b) Have at least 5 years' working experience preferably in engineering maintenance environment with at least 2 years in supervisory capacity;
- c) Possess sound technical knowledge and understanding of electrical / mechanical systems and proficient in at least one of them;
- d) Strategic thinker, resourceful and pro-active;
- e) Computer literate and able to operate basic software packages (e.g. Word, Excel, PowerPoint, Outlook, and engineering software);
- Possess good verbal and written communication skills, sound project management and inter-personal skills;
- g) Ability to adapt to new working environment, multi-task and work under pressure;
- h) Previous Rolling Stock / Railway System or related qualifications and / or working experience would be advantageous.

B. Duties

The incumbent shall be assigned in the Rolling Stock (consist of Light Rail Vehicles (LRV) / Depot Equipment) Group and in-charge of the following:

- 1. Responsible for Light Rail Vehicles (LRV) / Depot Equipment reliabilities;
- 2. Plan, organise, and optimise resources (manpower, machine/tools, methods etc.) to ensure Light Rail Vehicles (LRV) / Depot Equipment availability and performance meet the set targets;
- 3. Lead and manage the teams performing Preventive Maintenance (PM) and Corrective Maintenance (CM) of Light Rail Vehicles (LRV) / Depot Equipment;

- 4. Ensure that the quality procedures, policies and instructions are in place and in compliance;
- 5. Review work practices for continuous improvement;
- 6. Review and endorse engineering reports;
- 7. Lead and manage technical investigations, failure trend analysis and interfacing with staff from other Sections on technical issues related to Light Rail Vehicles (LRV) / Depot Equipment;
- 8. Track Light Rail Vehicles (LRV) / Depot Equipment faults, troubleshoot and recommend corrective and preventive actions;
- 9. Manage contracts with external parties, where required;
- 10. Review training needs and requirements of the Rolling Stock Group;
- 11. Conduct periodic supervision of staff work;
- 12. Conduct test and validation of procured parts;
- 13. Prepare status report(s) for the Rolling Stock Group; and
- 14. Perform other tasks and related duties as assigned.
