#### A. Qualifications

Candidates shall have the following attributes:

- a) Possess a Bachelor degree in any Engineering discipline from a recognised University or an equivalent qualification acceptable to the Board of MEL;
- b) Have at least 5 years' working experience in a supervisory capacity (experience in the railway industry will be an added advantage);
- c) Well-versed with ISO 9001 Quality Management Systems (QMS) and posses good understanding of its requirements;
- d) Possess sound knowledge of methodologies of quality assurance and standards;
- e) Possess outstanding verbal and written communication skills, numerical skills and understanding of data analysis / statistical methods;
- f) Brilliant organisational and leadership abilities, with great attention-to-details and resultsdriven approach, with strong IT knowledge including databases.

The incumbent shall be in-charge of the following:
