- Lead and manage the teams performing Preventive Maintenance (PM) and Corrective Maintenance (CM) of the Permanent Way & Infrastructure Systems Equipment;
- 4. Ensure that the quality procedures, policies and instructions are in place and in compliance;
- 5. Review work practices for continuous improvement;
- 6. Review and endorse engineering reports;
- Lead and manage technical investigations, failure trend analysis and interfacing with staff from other Sections on technical issues related to Permanent Way & Infrastructure Systems Equipment;
- Track Permanent Way & Infrastructure Systems Equipment faults, troubleshoot, and recommend corrective and preventive actions;
- 9. Manage contracts with external parties, where required;
- 10. Review training needs and requirements of the Permanent Way & Infrastructure Section;
- 11. Conduct periodic supervision of staff work;
- 12. Conduct test and validation of procured parts;
- 13. Prepare status report(s) for the Permanent Way & Infrastructure Section; and
- 14. Investigates, monitors, inspects and analyses existing permanent way and infrastructure conditions, prepares periodic and special reports and other necessary correspondence as assigned;
- 15. Highlight and Follow up on DLP issues
- 16. Prepare work instructions, monthly reports, Fault Investigation and Incident reports, Waiver of Nonconformity reports when and as required.
- 17. Monitor spare parts inventory and raise IR for procuring them.
- 18. Raise work orders, perform, review and close the work orders;
- 19. Follow-up of all faults/issues found during PM and raise CM work order;
- 20. Drive company vehicle, where required and possess a valid manual driving licence;
- 21. Provide support to ground staffs during heavy rainfall, cyclonic conditions and confinement or any force majeure and plan for preparedness and recovery actions.

- 22. Report on actual work performed against the scheduled work program and report any equipment performance and condition irregularities;
- 23. To perform such other duties related to the main duties listed above or related to the roles ascribed to him.
